Please note that the permit is not a hunting or fishing license – you must obtain these from proper authorities. Permission to enter and use the permit area are conditional on your compliance with all rules and restrictions and may be revoked at any time if you fail to comply. You must at all times have this permit in your possession while on Native Corporation lands. You must also have photo identification on your person and present it to security officers upon request.
